### 4. First-aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. **Methods and materials for containment and cleaning up**

Refer to attached safety data sheets and/or instructions for use. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Sweep up or gather material and place in appropriate container for disposal. The product is immiscible with water and will sediment in water systems. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. 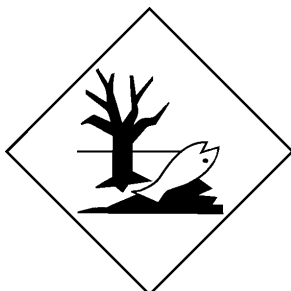
