Methods and materials for containment and cleaning up

ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Keep combustibles (wood, paper, oil, etc.) away from spilled material. This product is miscible in water. This material is a water pollutant and should be prevented from contaminating soil or from entering sewage and drainage systems and bodies of water. Prevent entry into waterways, sewers, basements or confined areas. Stop leak if you can do so without risk. Use clean non-sparking tools to collect absorbed material.
